Ten Thousand and no/100----- DOLLARS

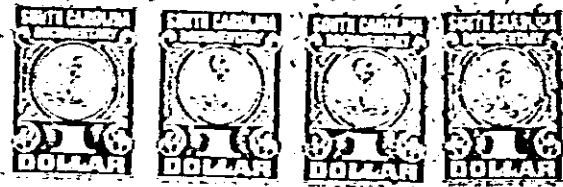

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville, being known and designated as Lot 18 on a plat of Sherwood Forest, which plat is of record in the R.M.C. Office for Greenville County in Plat Book BB-30 and having, according to said plat, the following metes and bounds, to-wit:
