All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northeastern corner of Richbourg Road and Andover Road, shown as Lot 66 on plat of Heritage Hills recorded in the R. M. C. Office for Greenville County in Plat Book YY, at page 187 and described as follows:

Beginning at an iron pin on the eastern side of Richbourg Road, joint front corner of Lots Nos. 66 and 67, and running thence with the line of Lot No. 67, N. 67-18 E. 163.8 feet to pin; thence S. 26 E. 140 feet to pin on the northern side of Andover Road; thence with the northern side of Andover Road, S. 67-26 W. 138.3 feet to pin; thence with the curve of the intersection, the chord of which is N. 69-18 W. 36.5 feet to pin on Richbourg Road; thence with the eastern side of Richbourg Road, N. 26-02 W. 115 feet to the point of beginning.
