(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY-FOUR THOUSAND SIX HUNDRED AND NO/100 \_\_\_\_\_ DOLLARS

(\$ 24,600.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, shown and designated as Lot 29, Mountain Shadows Subdivision, plat of which is recorded in the REC Office for Greenville County, S. C., in Plat Book 4N, Page 7, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Wheatridge Drive at the joint front corner of Lots 29 and 30 and running thence with the corner line of said lots N 41-0 W 150 feet to an iron pin; thence N 49-0 E, 139 feet to an iron pin on the southwesterly side of Plano Drive; thence with said Drive S 36-08 E 125.6 feet to an iron pin; thence around a curve at the intersection of Plano Drive and Wheatridge Drive, the chord of which is S 6-26 W 36.7 feet to an iron pin on Wheatridge Drive; thence with said Drive S 49-0 W 100.9 feet to the point of beginning.
