WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----

Sixty One Thousand and No/100----- DOLLARS
(\$ 61,000.00), with interest thereon at the rate of-----Eight----- per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwesterly side of Wellington Avenue, in the City of Greenville, and having according to a plat prepared by Carolina Engineering & Surveying Co. entitled "Survey for J. R. McQueen & Robert L. Smith" dated December 2, 1969, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwesterly side of Wellington Avenue, which pin is located 230 feet in a northwesterly direction from the westerly corner of the intersection of U. S. Highway No. 29 and Wellington Avenue and running thence S. 52-45 W. 183.8 feet to an iron pin; thence N. 37-22 W. 172.1 feet to an iron pin; thence N. 62-02 E. 89 feet to an iron pin; thence N. 52-44 E. 97 feet to an iron pin on the southwesterly side of Wellington Avenue; thence along the said Avenue S. 37-01 E. 157.5 feet to an iron pin, the point of beginning.
