All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, and known and designated as Lot #71, of a subdivision known as Homestead Acres, according to plat prepared by J. Mac Richardson, Engineer, dated November 1959, and recorded in the R.M.C.
