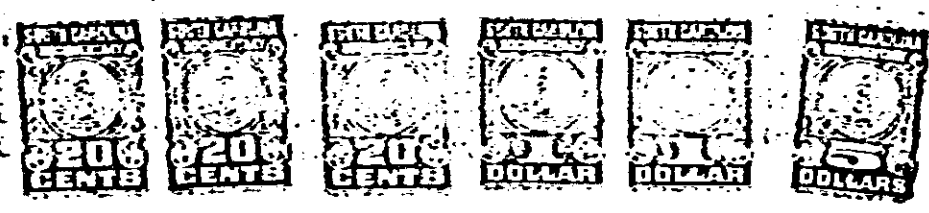

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 13 on plat of Greenfields Subdivision recorded in plat book XX page 103 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the west side of Greenfield Court, the joint front corner of Lots Nos. 13 & 14; thence with the joint line of said lots S. 72-01 W. 170.9 feet to an iron pin the rear corner of Lot No. 4; thence with the rear line of said lot S. 17-50 E. 105 feet to an iron pin corner of Lot No. 12; thence with the line of said lot N. 71-13 E. 88.3 feet to an iron pin on the west side of the turn-around of Greenfield Court; thence with the curve of said street, the chord of which is N. 6-30 E. 35 feet to a point; thence N. 33-38 E. 60 feet to a point; thence continuing N. 13-45 E. 40 feet to the beginning corner.
