R. W. Manley and Eva Mae Manley

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Thousand and No/100 -----

DOLLARS (\$ 15,000.00), with interest thereon from date at the rate of five & one-half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Butler Township, being known and designated as Lot No. 115 of Section 2, McSwain Gardens, as shown on Plat recorded in Plat Book LL, at page 137, R.M.C. Office for Greenville County, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Beaufort Street, front corner of Lots Nos. 114 and 115; thence with the line of said lots, N. 25-41 W. 146.2 feet to an iron pin; thence N. 64-19 E. 150 feet to an iron pin on Richbourg Road; thence with said Road, S. 23-E. 135 feet to a stake; thence around a curve to the right, the chord of which is S. 22 W. 21.2 feet to a stake on Beaufort Street; thence with said Street as follows: S. 67 W. 85 feet; thence S. 63 W. 42.8 feet to the beginning corner.
