All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 8 on a plat of Sectionland Section 2 of Holly Hill Subdivision, dated February 17, 1977, amended April 5, 1977, and recorded in Plat Book 5-P at page 85 in the RMC Office for Greenville County, reference being made to said plat for a more complete metes and bounds description.

This being the same property conveyed to Mortgagor herein by deed of Franklin Enterprises, Inc. dated November 28, 1977, and recorded in the RMC Office for Greenville County, South Carolina in Deed Book 1069 at Page 307
