TO ALL WHOM THESE PRESENTS MAY CONCERN:

MAGGIE LOU SIMS 17311
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Eight Thousand and no/100-----
DOLLARS (\$ 8,000.00), with interest thereon from date at the rate of **Six (6%)**

per centum per annum, said principal and interest to be repaid in monthly instalments of -----

Sixty-three and no/100----Dollars (\$ 63.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot No. 1, Block A, of East Highlands Estates, recorded in the RMC Office for Greenville County in Plat Book K at Pages 35 and 36, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Highland Drive, at joint front corner of lots Nos. 1 and 2, and running thence with line of lot No. 2, N. 52-43 W. 262.3 feet to an iron pin in a five foot right of way for utilities; thence with said five foot strip reserved for utilities, N. 38-23 E. 76.8 feet to an iron pin on Laurens Road; thence with Laurens Road, S. 52-00 E. 196.9 feet to an iron pin; thence with the curve of Highland Drive, the chord of which is S. 3-28 E. 98 feet to the beginning corner.
