All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 35 on plat of Addition to Section 2, Belle Terre Acres, Sheet No. 3, recorded in Plat Book 4X at page 1 and having the following courses and distances:
