(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FOUR THOUSAND AND NO/100 ----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Brushy Creek Road, being shown and designated as Lot No. 6 on Plat of Carriage Estates, recorded in the RMC Office for Greenville County, S.C. in Plat Book PPP at page 15 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of Brushy Creek Road, at the joint front corner of Lots No. 6 and 7 and running thence with the joint line of said lots, S. 4-27 W., 184.2 feet to an iron pin; running thence N. 85-00 W., 100 feet to an iron pin; running thence with the joint line of Lots No. 5 and 6; N. 4-27 E., 183.2 feet to an iron pin on the southerly side of Brushy Creek Road; thence with the southerly side of Brushy Creek Road, S. 85-33 E., 100 feet to the point of beginning.
