TO ALL WHOM THESE PRESENTS MAY CONCERN: That we, William T. Robertson  
and Nancy G. Robertson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of  
- - - - - Thirty-eight thousand two hundred fifty - - - - - DOLLARS

(\$ 38,250.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Boulder Road, being shown and designated as Lot 30 on a Plat of Forrester Woods, recorded in the RMC Office for Greenville County in Plat Book 4-N, at Page 78, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the western side of Boulder Road, joint front corner of Lots 29 and 39, and running thence with the common line of said Lots, N 62-24 W, 160 feet to an iron pin; thence along the common line of Lots 30 and 31, N 27-36 E, 110 feet to an iron pin; thence along the common line of Lots 30 and 33, S 62-24 E, 160 feet to an iron pin on Boulder Road; thence with said Road, S 27-36 W, 110 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of Charles C. Turner and Carline M. Turner, dated September 9, 1976, recorded September 10, 1976, in the RMC Office for Greenville County in Deed Book 1042 at Page 656

"In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.
