WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Eight Thousand and no/100-----

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 9 as shown on the plat of Pine Valley Estates, Section 1 prepared by Dalton and Neves, Engineers and recorded in the RMC Office of Greenville County, dated February 1960 in Plat Book MM at Page 138, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Pinehurst Drive, at the joint front corner of lots 8 and 9, and running thence with the joint line of said lots, N. 28-0 W. 160 feet to an iron pin; thence S. 62-0 W. 86.1 feet to an iron pin; thence with the joint line of lots 9 and 10 S. 26-36 E. 160 feet to an iron pin on the northwestern side of Pinehurst Drive; thence with the northwestern side of Pinehurst Drive N. 62-0 E. 90 feet to the point and place of beginning.
