WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being shown and designated as Lot 27 on plat of Boiling Springs Estates recorded in Plat Book YY at pages 14 and 15 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Browning Drive at the joint front corner of Lots 27 and 28 and running thence with the eastern side of Browning Drive, S. 25-51 E. 77 feet to pin; thence continuing with Browning Drive, S. 17-17 E. 145.1 feet to pin at rear of Tract 26; thence with the line of Tract 26, N. 72-43 E. 249.8 feet to point in branch; thence with the branch as a line, the chord of which is N. 5-22 E. 96.3 feet, N. 17-02 E. 234.3 feet, and N. 22-24 W. 68 feet to pin at rear corner of Tract 28; thence with the line of Tract 28, S. 55-50 W. 443.4 feet to the point of beginning, containing 2.32 acres and being the same property conveyed to the Mortgagors herein by deed recorded in Deed Book 743 at page 453.
