MORTGAGE OF REAL ESTATE

WHEREAS: BILLY J. HEGLER AND DORIS W. HEGLER  
OF Greenville County, S. C., hereinafter

called the mortgagor(s) is indebted to Cameron-Brown Company, a corporation organized and existing under the laws of the State of North Carolina, hereinafter called mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of SEVEN THOUSAND FIVE HUNDRED FIVE AND NO/100THS (\$7,505.00) Dollars, together with add-on interest at the rate of six (6%) per cent per annum, until paid in full, said principal and interest being payable at the office of Cameron-Brown Company in Raleigh, North Carolina, or at such place as the holder of the note may designate in writing delivered or mailed to the mortgagor(s), in monthly installments of One hundred twenty-six and 87/100ths (\$ 126.87 ) Dollars, commencing on the fifteenth day of May, 19 73, and continuing on the fifteenth day of each month thereafter for eighty-three months, with a final payment of ( \$ 126.89 ) until the principal and interest are fully paid, provided, however, that if not sooner paid the entire indebtedness shall be due and payable on the fifteenth day of April, 19 80; the mortgagor(s) shall have the right to prepay or anticipate payment of this debt in whole or in part at anytime, in amounts not less than the aforesaid monthly installments, and shall receive a rebate for any charged-but-unearned interest, computed in accordance with the Standard Rule of 78.

NOW, BE IT KNOWN TO ALL, that the mortgagor(s), in consideration of the aforesaid debt and sum of money, and for the purpose of securing the payment thereto to the mortgagee, and also in consideration of the further sum of Three Dollars, paid to the mortgagor(s) by the mortgagee, receipt of which is hereby acknowledged at and before the sealing and delivery of these presents, has granted, bargained, sold, assigned, and released, and by these presents do grant, bargain, sell, assign and release unto the mortgagee, its successors or assigns, the following described property, to-wit:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in the Town of Simpsonville, being located on the southeastern side of Morgan Circle and being known and designated as Lot No. 41 on plat of subdivision known as ROLAND HEIGHTS, as shown by plat thereof recorded in Plat Book S at page 30 in the R. M. C. Office for Greenville County, South Carolina. Said lot fronts 80 feet on the southeastern side of Morgan Circle and has a depth of 175 feet on each side and is 80 feet across the rear.

This mortgage is second and junior in lien to that certain mortgage in favor of C. Douglas Wilson & Co., assigned to Metropolitan Life Insurance Company, dated May 31, 1966, in the original amount of \$13,050.00, recorded in the R. M. C. Office for Greenville County in REM Volume 1032 at page 391.
