WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY NINE THOUSAND, FIVE HUNDRED AND FIFTY AND No/100----- DOLLARS

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the western side of Dexter Drive, and being known and designated as Lot 70 on a plat of Drexel Terrace, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ at Page 177, and having, according to said plat, the following metes and bounds, to-wit:
