WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Old Pelzer Road in the County of Greenville, State of South Carolina, being shown as Lot No. 4 on a plat of Spring Valley Subdivision, Section II, dated December 16, 1969, prepared by C. O. Riddle, recorded in Plat Book 4-F at Page 10 in the R. M. C. Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:
