(hereinafter referred to as Mortgagor) SEND(S) GREETINGS

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-four Thousand and No/100 -----

(\$ 24,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the southeast side of East North Street in the City of Greenville, being shown as Lot 16 on plat of the property of Overbrook Land Company made by Jones, dated September 17, 1913, recorded in Plat Book E at Page 251 and described as follows:

BEGINNING at a stake on the southeast side of East North Street 86.3 feet southwest from Chestnut Street at the corner of Lot 17 and running thence with the line of said lots, S 41-29 E 184.8 feet to a stake; thence, S 39-42 W 91 feet to a stake at the corner of Lot 15; thence with the line of said lot, N 44-21 W 192.8 feet to a stake on East North Street; thence with the southeast side of said street, N 41-28 E 50 feet to a stake; thence, N 48-03 E 50 feet to the beginning corner.
