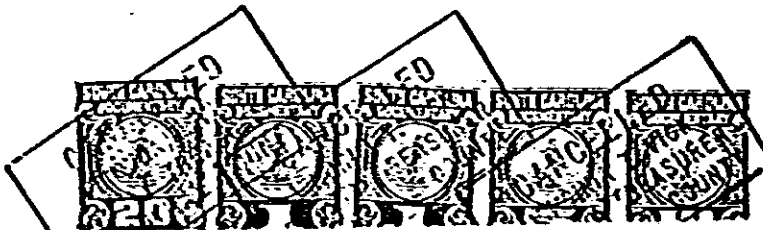

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, on the northeastern side of Highway No. 276 (Main Street), being that property shown on a plat entitled Property of Paul J. Foster and Norman W. Huff located in Mauldin, made by Robert R. Spearman, Registered Surveyor, dated January 29, 1975, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin at the joint front corner of instant property and property of McDonalds Corp., and running thence along the northeastern side of Main Street (Highway No. 276) N. 16-03 W. 30 feet, more or less, to an iron pin at the joint front corner of instant property and property now or formerly of Walter Griffin; thence along Griffin line N. 70-15 E. 556 feet to an iron pin in line of A.C.L. National Bank S. 78-49 W. 336.0 feet to an iron pin; thence along line of McDonalds Corp. N. 17-12 W. 205.55 feet to an iron pin; thence still along the line of McDonalds Corp. S. 70-15 W. 225.0 feet to an iron pin, the point of beginning.
