All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot #41 on plat of Gray Fox Run made by C. O. Riddle, Surveyor, November 6, 1975 and recorded in the RMC Office for Greenville County in Plat Book 5P at Page 9. According to said plat, the property is more fully described as follows:

BEGINNING at an iron pin on Gray Fox Square at the joint corner of Lots 41 and 42 and running thence along the joint line of said lots S. 59.57 E. 137.6 feet to an iron pin; thence S. 82-56 W. 91.2 feet to an iron pin in the line of Lot 39; thence with line of Lot 39 N. 22-31 W. 47.9 feet to an iron pin at the line of Lot 40; thence with line of Lot 40 N. 2-36 E. 105 feet to an iron pin on Gray Fox Square; thence with said Square N. 88-22 E. 49.4 feet to an iron pin, the point of beginning.
