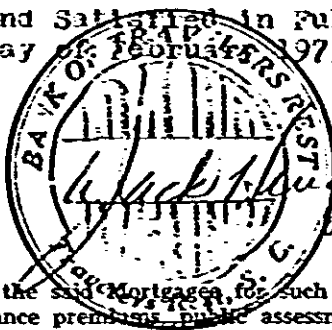

M. C. Office for Greenville County in Plat Book I at Pages 111-112, and being further described according to said plat as follows:
