TO ALL WHOM THESE PRESENTS MAY CONCERN:

John J. Edwards and Geraldine P. Edwards

(hereinafter referred to as Mortgagee) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Thousand and no/100 DOLLARS

(\$ 30,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the western side of Downing Place and known and designated as Lot No. 59 of a subdivision known as Westminister Village, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 5-P at Page 40 and according to said plat has the following netes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Downing Place at the joint front corner of lots 58 and 59 and running thence with the joint line of said lots N. 76-31 W., 152.71 feet to an iron pin in the line of Lot No. 57; running thence S. 35-52 W., 98 feet to an iron pin in the line of property now or formerly of the Greenville County School Board; running thence S. 38-45 E., 75 feet to an iron pin at the joint rear corner of Lots 59 and 60; running thence with the joint line of said lots N. 77-31 E., 167.97 feet to an iron pin on Downing Place; running thence with the curve of Downing Place, the chord of which is N. 04-21 W., 66.15 feet to an iron pin, the point of beginning.
