All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in **Bates Township, on the Northern side of the Buncombe Road, about one mile North of Travelers Rest, adjoining lands of T. H. Peterson, J. F. Child and Mattie Case Estate, and described as follows:**
