(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Seventy One Thousand and No/100 ----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, as shown on a plat of the property of Julia Barrow Robinson made by Dalton & Neves, February, 1956, said plat being recorded in Plat Book JJ, page 119, in the R.M.C. Office for Greenville County, South Carolina. Said property being approximately 3.62 acres and according to said plat, having the following metes and bounds, to-wit:
