TO ALL WHOM THESE PRESENTS MAY CONCERN: WE, Gerald J. Bender and Lois G. Bender

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Eight Thousand, Four Hundred and No/100 ----- DOLLARS

(\$28,400.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern corner of the intersection of Kensington Road with Ravensworth Road, being known and designated as Lot No. 110 on plat of BROOK GLENN GARDENS, made by Piedmont Engineers & Architects, dated October 28, 1965, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book JJJ, page 85 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Ravensworth Road at the joint front corner of Lots Nos. 109 and 110 and running thence with the common line of said lots, N 6 12 E 145.0 feet to an iron pin; thence S 83 50 E 140.1 feet to an iron pin on the western side of Kensington Road, thence with the western side of Kensington Road; thence with the western side of Kensington Road, S 6 00 W 120 feet to an iron pin at the intersection of Kensington Road and Ravensworth Road; thence with the curve of the intersection of said Roads, the chord of which is S 51 08 W 35.15 feet to an iron pin on the northern side of Ravensworth Road; thence with the northern side of Ravensworth Road, N 83 45 W 115.55 feet to an iron pin, the point of BEGINNING.
