All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 93 on the northern side of Mimosa Drive on plat of Heritage Hills recorded in the RMC Office for Greenville County in Plat Book YY, Page 187, and having, according to said plat, the following metes and bounds, to-wit:
