WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-five thousand six hundred and no/100----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 367 on a plat entitled Del Norte Estates, Section III, prepared by Piedmont Engineers & Architects, dated May 3, 1971, recorded in the RMC Office of the Greenville County Courthouse in Plat Book 4N at Pages 14 and 15 being described according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the Western side of Welwyn Court at the joint front corner of Lots 367 and 368 and running thence S39-45 W. 135.7 feet to an iron pin at the joint rear corner of said Lots; thence along the rear line of Lot 367 S 53-00 E 10 feet to an iron pin; thence continuing on said course 140 feet to an iron pin at the joint rear corner of Lots 366 and 367; thence along the common line of said Lots N 6-30 E 153.6 feet to an iron pin on Welwyn Court at the joint front corner of said Lots; thence along Welwyn Court the following courses and distances: N 69-57 W 35 feet, N 29-59 W 35 feet to an iron pin, the point of beginning.
