 TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Glen Lester Hensley and Mary Hilton Hensley

(hereinafter referred to as Mortgagor) is well and truly indebted unto Corinne M. Williams

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Five Hundred Twenty-Five and 16/100ths-----

Dollars (\$ 7,525.16) due and payable

in successive monthly installments of \$84.12, commencing on the first day of September, 1975, and continuing on the first day of each month thereafter until paid in full; with said payments to be applied first to interest and then to principal;

with interest thereon from _____ date _____ at the rate of 7% per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the northwestern side of Crestfield Road and being shown on a plat entitled "Property of Mrs. G. G. Williams" prepared by Dalton and Neves and recorded in the RMC Office for Greenville County in Plat Book RRR, Page 135 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Crestfield Road and running thence N. 34-15 W. 259.7 feet to an iron pin; thence S. 60-51 W. 60 feet to an iron pin; thence S. 3-00 E. 327.1 feet to an iron pin on the northwestern side of Crestfield Road; thence with Crestfield Road N. 51-38 E. 230 feet to an iron pin, the point of beginning.

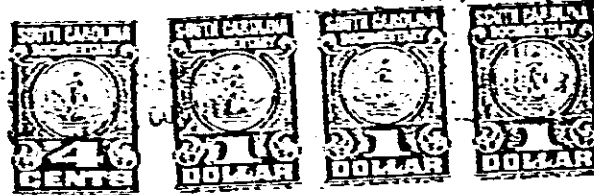
