~~ALL THAT CERTAIN PARCEL OR LOT OF LAND SITUATE, LYING AND BEING ON THE SOUTHERN SIDE OF SEABURY DRIVE NEAR THE CITY OF GREENVILLE, COUNTY OF GREENVILLE, STATE OF SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS LOT #97 AS SHOWN ON PLAT OF MERRIFIELD PARK, PREPARED BY C. O. RIDDLER, DATED OCTOBER 1967, RECORDED IN THE R.M.C. OFFICE FOR GREENVILLE COUNTY IN PLAT BOOK 000, AT PAGE 177, AND HAVING, ACCORDING TO SAID PLAT, THE FOLLOWING METES AND BOUNDS:~~

ALL that piece, parcel or lot of land situate, lying and being on the southern side of Seabury Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #97 as shown on Plat of Merrifield Park, prepared by C. O. Riddle, dated October 1967, recorded in the R.M.C. Office for Greenville County in Plat Book 000, at Page 177, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southern side of Seabury Drive at the joint front corner of Lots #97 and #98, and running thence with the line of Lot #98 S. 5-00 E. 219 feet to an iron pin; thence with the line of property now or formerly of Lucile J. Young S. 70-28 E. 120.9 feet to an iron pin; thence with the line of property now or formerly of C. M. Guest, N. 5-00 W. 296.2 feet to an iron pin; thence with the curve of the southern side of Seabury Drive, the chord of which is S. 55 W., 50 feet to an iron pin; thence continuing with the curve of the southern side of Seabury Drive, the chord of which is N. 75-00 W., 50 feet to an iron pin; thence continuing with the southern side of Seabury Drive S. 85-00 W. 23.4 feet to the point of beginning.
