TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Venna G. Howard

(hereinafter referred to as Mortgagor) is well and truly indebted unto Southern Service Corporation

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight thousand five hundred and 00/100 Dollars (\$8,500.00) due and payable

according to the terms thereof, said note being incorporated herein by reference

with interest thereon from date at the rate of nine (9%) per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 153 of a subdivision known as Canebrake II, Sheet 1 according to revised plat thereof prepared by Arbor Engineering, Inc. dated June, 1979 and revised November 21, 1979 being recorded in the RMC Office for Greenville County in Plat Book 7-C at page 79 and having, according to said plat, such metes and bounds as appear thereon.

This is the same property conveyed to the mortgagor by deed of College Properties, Inc. dated July 14, 1980 and recorded in the RMC Office for Greenville County in Deed Book 1127 at page 287.

This is a second mortgage, junior in lien to that certain mortgage given by Venna G. Howard to First Federal Savings and Loan Association on July 15, 1980 and being recorded in the RMC Office for Greenville County in Mortgage Book 1507 at page 838.

This second mortgage shall be payable in full when builder either rents, leases with or without option to purchase, gives a bond for title, sells the house and lot, or two years from the date of this mortgage, whichever occurs first.
