TO ALL WHOM THESE PRESENTS MAY CONCERN:

FIRST PIEDMONT MORTGAGE COMPANY, INC.

All that certain piece, parcel or tract of land containing about 17.6 acres situate, lying and being adjacent to S. C. Highway 291 and Greenland Drive in the County of Greenville, State of South Carolina, being more particularly described on Exhibit "A" attached hereto and by this reference made a part hereof.

This property is the same property conveyed to Mortgagor by Eighth Colony Investors by deed dated November 30, 1978 recorded in Deed Book 1095 at Page 137.

This mortgage is supplemental to and not in substitution for those certain mortgages on the above described property from Eighth Colony Investors to Mortgagor recorded in Book 1311 at Page 699 and Book 1329 at Page 897 assigned to Mortgagee and constitutes additional security to Mortgagee for the same indebtedness.

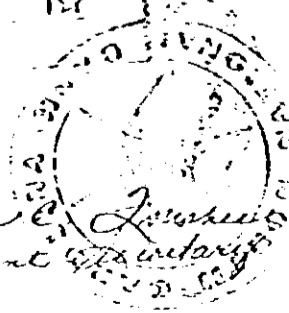
