THIS MORTGAGE is made this 15th day of March 1976, between the Mortgagor, Thomas W. Taylor and Valerie K. Taylor (herein "Borrower"), and the Mortgagee, Federal Savings and Loan Association, a corporation organized and existing under the laws of South Carolina, whose address is P. O. Box 10148, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty-Five Thousand One Hundred Fifty and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated March 15, 1976 (herein "Note"), providing for monthly installments of principal and interest, BEGINNING at an iron pin on the Southeastern side of East Faris Road at the joint front corner of Lots Nos. 23 and 24, and running thence S. 26-30 E. 217 feet along line of Lot No. 24 and Lot No. 10 to an iron pin; thence S. 63-35 W. 99 feet through Lot No. 9 and into Lot No. 8 to an iron pin; thence N. 26-30 W. 217 feet through Lot No. 8 and through center of Lot No. 22 to an iron pin on the Southeastern side of East Faris Road; thence N. 63-35 E. 99 feet along the Southeastern side of East Faris Road to the point of beginning.
