WHEREAS, the Mortgagor is well and truly indebted unto
FIRST NATIONAL BANK OF SOUTH CAROLINA
(hereinafter referred to as Mortgagee) as evidenced by the Mortgagee's
promissory note(s) of even date herewith, the terms of which are
incorporated herein by reference, in the sum of One Hundred Thousand and
No/100ths
DOLLARS (\$ 100,000.00), with interest thereon as provided in said
promissory note(s), said principal and interest to be paid as therein
stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said
Mortgagee for such further sums as may be advanced to or for the Mortgagor's
account for taxes, insurance premiums, public assessments, repairs, or
for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid,
shall be due and payable July 1, 1980.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the afore-
said debt, and in order to secure the payment thereof and of any other and
further sums for which the Mortgagor may be indebted to the Mortgagee at
any time for advances made to or for his account by the Mortgagee, and to
secure the performance of all the covenants, conditions, stipulations and
agreements contained herein and/or in any other documents given by the
Mortgagor to the Mortgagee in connection therewith, and also in consideration
of the further sum of Three Dollars (\$3.00) to the Mortgagee, and well
and truly paid by the Mortgagor at and before the sealing and delivery of
these presents, the receipt whereof is hereby acknowledged, has granted,
bargained, sold and released, and by these presents does grant, bargain,
sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon,
or hereafter constructed thereon, situate, lying and being in Greenville
County, State of South Carolina, being located on the northern side of
Toy Street as shown on plat entitled "Property of School District of Greenville
County", dated March 25, 1974, prepared by Campbell & Clarkson, Surveyors,
and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Toy Street at corner of
property herein described and undeveloped alley, and running thence with line
of said undeveloped alley, N. 77-10 E. 250 feet to an iron pin; thence S. 14-
248.3 feet to an iron pin; thence S. 69-52 W. 250.5 feet to an iron pin on
the northern side of Toy Street; thence with the northern side of Toy Street,
