MORTGAGE

THIS MORTGAGE is made this 10th day of January, 1975, between the Mortgagor, Michael K. Brown and Janice P. Brown (herein "Borrower"),

and the Mortgagee, The South Carolina National Bank, a corporation organized and existing under the laws of United States of America, whose address is Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty Thousand, One Hundred and No/100----- Dollars, which indebtedness is evidenced by Borrower's note of even date herewith (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on January 1, 2005.

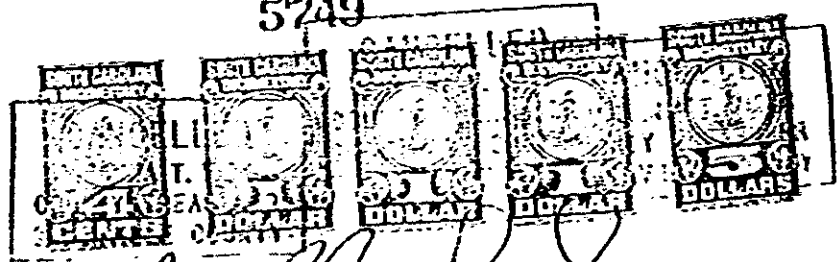
