THIS MORTGAGE, executed the 9th day of May, 1983, by Terrell T. Leeke and Roseanne H. Leeke (hereinafter referred to as "Mortgagor") to First National Bank of South Carolina (hereinafter referred to as "Mortgagee") whose address is P.O. Box 2568, Greenville, South Carolina, 29602.

WITNESSETH:

IN CONSIDERATION of the sum of Three Dollars (\$3.00) paid to Mortgagor by Mortgagee and in order to secure the payment of a promissory note including any renewal, extension or modification thereof (hereinafter referred to as the "Note"), dated \_\_\_\_\_, to Mortgagee for the principal amount of One hundred thirty-six thousand and no/100 Dollars, plus interest thereon and costs of collection, including attorneys' fees, and to further secure all future advances or re-advances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note or any renewal, extension or modification thereof or evidenced by any instrument given in substitution for said Note, Mortgagor has granted, bargained, sold and released to Mortgagee and the successors and assigns of Mortgagee, and by this Mortgage does grant, bargain, sell, and release to Mortgagee and the successors and assigns of Mortgagee, all the following real property (hereinafter referred to as the "Property"):

ALL that piece, parcel or tract of land being shown as 5.0 acres on a plat of property of Dr. Terrell T. Leeke and Roseanne H. Leeke prepared by W. R. Williams, Jr. P.E., on September 17, 1980 and revised April 25, 1983, which plat is recorded in R.M.C. Office, Greenville County, in plat book 9K, page 29, in which property has, according to said plat, the following metes and bounds to wit:
