- (A) Mortgage—This document, which is dated June 6, 1983, will be called the "Mortgage".

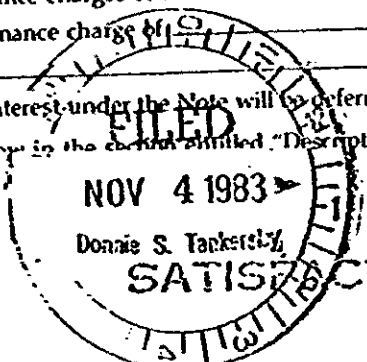
