THIS MORTGAGE is made this 12th day of September 1980, between the Mortgagor, Michael A. Yoder and Dorothy T. Yoder (herein "Borrower"), and the Mortgagee, HERITAGE FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of the United States of America, whose address is 201 West Main Street, Laurens, S.C. 29360 (herein "Lender").

This mortgage includes a renegotiable rate mortgage rider which is hereby incorporated by reference and made a part hereof.
WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty-Eight Thousand Five Hundred (\$28,500.00) Dollars, which indebtedness is evidenced by Borrower's note dated September 12, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on further providing for renewals at intervals of every 3 years with adjustments to interest rates and monthly payments at each renewal; with final maturity on 9-1-2010 at which time the balance of indebtedness, if not sooner paid, shall come due and payable.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"). Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, in the Town of Simpsonville being known and designated as Lot No. 659, Sheet 2, Section VI of Westwood Subdivision as shown on plat thereof recorded in Plat Book 5P, at Page 35, in the RMC Office for Greenville County, South Carolina; reference to which plat is hereby made for a more particular description.

This is the same property conveyed to the mortgagors herein by deed of Arthur L. Collins, Jr., and Deborah H. Collins, dated September 12, 1980, which is being simultaneously recorded in the RMC Office for Greenville County, S.C., in Deed Book 1133, at Page 194.
