with interest thereon from date at the rate of 8 per centum per annum, said principal and interest to be All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Zara Street, being known and designated as lot no. 4 on a plat of the property of Central Realty Corporation made by W. J. Riddle, dated February 2, 1946, recorded in the R.M.C. Office of Greenville, South Carolina in Plat Book B at page 105 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the southeastern side of Zara Street 143.3 feet from the intersection of Maco Street and Zara Street at the joint corner of lots 1 and 4 and running thence with the southeastern side of Zara Street, N. 64-30 E. 50 feet to a point at the corner of lot no. 5; thence with the joint line of said lots 4 and 5, S. 25-30 E. 150 feet to point; thence S. 64-30 W. 50 feet to an iron pin at the joint rear corner of lots nos. 4 and 3; thence with the joint line of lot 4 and the rear line of lots nos. 1, 2 and 3, N. 25-30 W. 150 feet to an iron pin on the southeastern side of Zara Street, the point of beginning.
