Subject: Re: Greenville County Flood Hazard Mitigation Plan Annual Progress Update

Greenville County participates in the Community Rating System (CRS) of the National Flood Insurance Program. This program commitment enhances public safety and property protection while providing our flood insurance policyholders with a premium discount. The County Flood Hazard Mitigation Plan is incorporated into the Multi-Jurisdictional Hazard Mitigation Plan (Plan) adopted by County Council on June 16, 2020. This Flood Hazard Mitigation Plan Update is an annual review that is transmitted to the local governing body; the State Flood Mitigation Program Administrator; and, the general public in accordance with CRS program requirements. The Plan and the activities summary update are available in the Floodplain Administrator's Office for public review and on the County's Floodplain Web page. This annual report is designed to document and evaluate progress toward implementing the flood hazard mitigation objectives of the Plan. The hazard mitigation committee met on June 18, 2021 and a copy of the meeting minutes along with the status of each mitigation initiative is attached.

Additionally the floodplain management department completed their annual repetitive loss area analysis of insured structures that has had at least two paid flood losses of more than \$1000 each in any ten year period since 1978. After our review, the county currently has 13 repetitive loss structures. A total of 91 notices were sent out which included the 13 repetitive loss properties and surrounding property owners with similar flooding risk. A copy of the letter is attached.

Greenville County staff is committed to achieving the flood hazard mitigation goals outlined in our Plan. We appreciate the support of Council, County Administration and our Disaster Mitigation Committee members as we work together to make Greenville County a more disaster resistant community.

ITEMS DISCUSSED: 2021 Annual Update - Multi-jurisdictional Hazard Mitigation Plan

Woolpert presented information regarding the Hazard Mitigation Plan's (HMP) history of development, the Disaster Mitigation Committee (DMC), the hazards of concern and the overarching mitigation strategies contained within the HMP. The facilitator then reviewed each of the mitigation initiatives identified in the 2020 HMP including the following:

- A brief description of the initiative
- Current status
- Priority Ranking
- Funding Source

During the meeting, several of the initiatives were updated to the correct status. A list of all initiatives with their status and funding are contained within these meeting minutes. Following the discussion of the currently identified mitigation initiatives was a discussion of potential new initiates and edits to current initiatives. Those comments and recommendations are recorded below.

Comments and Recommendations:

Kirsten Robertson: Should the Soil and Water Conservation District be on list of stakeholders list since the District maintains nine (9) dams?

Response: Yes, the District will be added as a stakeholder and dams should be considered in future planning.

Geoffrey Habron: Does the HMP include anticipated changes in forecast frequency and magnitude of potential storm events?

Response: Yes, the plan requires consideration of climate change. Further, while Greenville County floodplain management activities are based on the 100-year flood, County prepared watershed plans consider both future built out conditions of the watershed and the 500-year flood event.

Geoffrey Habron: There are several watershed projects and 319 grants underway in the Saluda River basin that could be included in the plan.

Response: The County can contact Friends of the Saluda for data regarding both planned projects and projects that are underway. Flood reduction / management impacts would need to be quantified.

Geoffrey Habron: Consider using NOAA's Climate Explorer Tool in next plan update. https://crt-climate-explorer.nemac.org/

Response: The County will include this site as a reference for the next plan update.

The meeting agenda and attendee list is attached following the list of initiatives. Presentation material was provided to the committee under separate cover and a recording of the meeting was submitted to the County.

To: Repetitive Loss Area Property Owners

Re: Repetitive Loss Areas and Floodplain Management Information

National Flood Insurance Program (NFIP)

Dear Sir or Madam:

You are receiving this letter because you own and/or reside in a home located in an area that is subject to flooding. In fact, one or more properties located in your area have experienced "repetitive losses" due to flooding. Repetitive loss properties are those properties for which two or more claims of more than \$1,000 have been paid by the NFIP within any 10-year period since 1978. Although repetitive loss properties represent only 1% of all the NFIP's insurance policies, they have accounted for nearly one-third of the claim payments.

Greenville County is concerned about repetitive flooding and has an ongoing program to address problem flooding areas. However, there are things that each property owner can do to protect themselves from damage caused by flooding events. The enclosed Brochure provides information on flooding issues and floodplain management such as:

Property Protection Measures
Flood Safety

Permit Requirements
Flood Insurance
Natural and Beneficial Functions

Greenville County also has a program to assist residents whose structures are located in floodplain areas and/or have experienced structural flood damage. The Residential Elevation Grant Program will provide up to \$7,500 to elevate flood prone homes which meet eligibility requirements. 
Property Protection Measures*

Every year, flooding in the United States causes more property damage than any other type of natural disaster. While recent improvements in construction practices and regulations have made new homes less prone to flood damage, there are many existing homes susceptible to flood losses. Flooding of these properties can be minimized through the following measures:

- Elevate your home above the flood level,
- Keeping debris and trash out of the streams and ditches,
- Grading your yard to correct local drainage problems, and
- Emergency measures can include moving furniture and sandbagging.

Drainage System Maintenance

Greenville County has a drainage system inspection and maintenance program. The Public Works Department routinely conducts inspections on right-of-way ditches. Debris, even grass clippings, in ditches may obstruct the flow of water and cause overflow into the streets, yards, and homes. Greenville County Code Section 9-124 makes it illegal to take any action that will impede the flow of water in rights-of-way or dumping of debris into any right-of-way. Greenville County's floodplain management is the operation of a community program of corrective and preventative measures for reducing flood damage. Greenville County's Flood Damage Prevention Ordinance was enacted to protect human life and health, minimize property damage and encourage appropriate construction practices to minimize public and private losses due to flooding

Natural & Beneficial Functions*

Water quality is improved through the wetlands ability to filter nutrients and impurities from runoff and process organic wastes. These areas provide habitat for fish, waterfowl and wildlife, support a high rate of plant growth and maintain biodiversity and the integrity of the ecosystem. Floodplains provide green space for protection of streams from development and the forces of erosion. Please assist Greenville County to protect these natural resources by reporting any activity that can harm this resource such as broken silt fences, illegal dumping or placing fill within these areas.

Local Flood Hazard*

Flooding in our County occurs in several areas including, but not limited to, Brushy Creek, Rocky Creek, Gilder Creek and Welcome Creek as well as the Reedy, Saluda and Enoree Rivers. This results in water leaving channel banks during or soon after heavy storms. Floodwater may be as deep as two to three feet or higher. Basements, lower floors, garages, and cars may flood. If you live in one of these affected areas you are subject to repetitive flooding. You need to take precautions and be prepared for rising water during storm watches or warnings.

Flood Safety*

Do not walk through a flooded area. Currents can be deceptive; six inches of moving water can knock you off your feet. Do not drive through a flooded area. More people drown in their cars than anywhere else. Stay away from power lines and electrical wires. The number two flood killer, after drowning, is electrocution. Remember, "Turn Around, Don't Drown."

Flood Insurance*

If you don't have it, you need to get it by talking to your insurance agent. Homeowner's insurance policies do not cover damage from floods. However, because Greenville County participates in the National Flood Insurance Program (NFIP), you can purchase a separate flood insurance policy. This insurance is backed by the Federal government and is available to everyone, even for properties that have been flooded. Some people have purchased flood insurance because their lender required it when they obtained a mortgage or home improvement loan. Usually these policies cover the building's structure only and not the contents. If you are covered, you may want to check the amount and make sure you have contents coverage. Visit www.floodsmart.gov for more information.

Flood Warning

The National Weather Service along with the Greenville County Emergency Management Agency, provide flood warning and evacuation data to local radio (WFBC, WROQ, WTPT) and television (WHNS, WSPA, WLOS, WYFF) stations. Greenville County Sheriff's Office and area Fire Departments will provide door-to-door warnings to those areas threatened by flooding, when evacuations are ordered in areas expected to flood. Residents should be prepared to move to a place of safety. The County of Greenville in conjunction with the Greenville County Office of Emergency Management will announce emergency shelter locations.

Permit Requirements*

You must obtain a permit for all development within a regulated flood hazard area. All structures located on parcels of land that lie either wholly or partially within, or immediately adjacent to, areas of special flood hazard require a permit before construction. Flood Mitigation Program

A repetitive loss structure is a building covered by flood insurance issued under the NFIP, that has suffered flood damage on two occasions during a 10-year period in which the cost to repair the flood damage, on average, equaled or exceeded 25% of the market value of the structure at the time of each flood loss. Greenville County has a flood mitigation program to assist homeowners with elevation of their dwellings in an attempt to alleviate repeated flooding. This program consists of a grant from the County that will pay up to \$7,500 towards the elevation of an owner-occupied dwelling. For more information please contact the Floodplain Administrator.

Flood Services

Greenville County provides the following information. You may call (864-467-7523) or visit the Floodplain Administrator at County Square (Suite 4100) to determine if you are in a FEMA mapped flood hazard area. You may also request FEMA Elevation Certificates where available. FEMA Flood Insurance Rate Maps (FIRMs) may also be found on the County's GIS website (www.gcgis.org) under the FEMA layer. Also, flood protection references are available at the Greenville County Public Library in the South Carolina Room.
