#### **Referendum Question 1**

Shall the Board of Fire Control of Slater-Marietta Fire District, South Carolina be authorized to issue, either at one time as a single issue or from time to time as several separate issues, general obligation bonds of Slater-Marietta Fire District, South Carolina in the aggregate principal amount of not exceeding \$3,000,000, the proceeds of which shall be applied to defray the cost of (i) the acquisition, construction, installation, furnishing and equipping of a new fire station; (ii) renovations to existing fire stations; and (iii) the acquisition of one or more fire trucks, brush trucks and various items of equipment for the District, as well as related costs such as legal fees and costs of issuance of such bonds?

Yes, In Favor of the Question --- 65 votes
No, Opposed to the Question --- 29 votes

#### **Referendum Question 2**

Shall the Board of Fire Control of Slater-Marietta Fire District, South Carolina be authorized to increase the District's tax millage rate imposed for general operating purposes to not exceeding 60 mills?
