

**A RESOLUTION****TO PROVIDE FOR THE MILLAGE RATE TO BE LEVIED BY THE DUNKLIN FIRE DISTRICT.**

**WHEREAS**, the Dunklin Fire District is a special purpose district located wholly within the County of Greenville; and

**WHEREAS**, the Board of Commissioners for the District is authorized by law to annually levy, for operations and maintenance, ad valorem property tax millage and requested an increase of its present millage rate; and

**WHEREAS**, according to the provisions contained in S.C. Code Ann. § 6-11-275, as amended, special purpose districts located wholly within a county, which were in existence prior to March 7, 1973, and which have the statutory authority to annually levy taxes for operations and maintenance, are authorized to increase their respective millage limitations upon the written approval of the governing body of the county in which they are located; and

**WHEREAS**, on September 19, 2023 Greenville County Council held a public hearing and adopted Resolution No. 1939 authorizing the continuation of the millage for Dunklin Fire District for FY2023-2024 at a rate of 31.9 mills which included 29.9 mills for operations and maintenance and 2 mills for a reserve account; and

**WHEREAS**, the actual millage that was levied for FY2023-2024 was 35.3 mills (consisting of 33.3 mills for operations and maintenance and 2 mills for a reserve account) based on a 2023 Millage Certificate Form completed by Dunklin Fire District and certified by the Greenville County Auditor;

**NOW, THEREFORE, BE IT RESOLVED** that Greenville County Council ratifies the millage levied for Dunklin Fire District for FY2023-2024 and approves a total increase of five and five tenths (5.5) mills for the Dunklin Fire District for FY2024-2025 pursuant to S.C. Code § 6-1-320(A)(1) bringing the District's total operation and maintenance millage to thirty-five and four tenths (35.4) mills and continuing a two mill (2.0) levy for a reserve account for a combined total of 37.4 mills.

**BE IT FURTHER RESOLVED** that the millage increase authorized by this Resolution is effectuated pursuant to S. C. Code Ann. §§ 6-11-271 or 6-11-275, as amended.

**BE IT FURTHER RESOLVED**, that the Auditor and Tax Collector of Greenville County are hereby directed to levy and collect the millage rates authorized by this Resolution.
