ON SEPTEMBER 19, 2023, GREEN-VILLE COUNTY COUNCIL AUTHORIZED THE CONTINUATION OF THE ESTABLISHED MILLAGE RATE FOR THE DISTRICT FOR THE CONTINUATION OF THE ESTABLISHED MILLAGE RATE FOR THE DUNKLIN FIRE DISTRICT FOR FY2023-2024 AT 31.9 MILLS FOR OPERATIONS AND MAINTENANCE AND 2.0 MILLS FOR A RESERVE ACCOUNT. THE DUNKLIN FIRE DISTRICT BOARD OF FIRE CONTROL, PURSUANT TO THE PROVISIONS OF S.C. CODE ANN. SECTION 6-11-275, AS AMENDED, HAS REQUESTED THAT GREENVILLE COUNTY COUNCIL RATIFY THE ACTUAL MILLAGE RATE CERTIFIED BY THE DISTRICT OF 35.3 MILLS CONSISTING OF 33.3 MILLS FOR OPERATIONS AND 2.0 MILLS FOR A RESERVE ACCOUNT THAT WAS LEVIED FOR DUNKLIN FIRE DISTRICT FOR FY2023-2024; AND APPROVE A TOTAL INCREASE FOR FY2024-2025 OF FIVE AND FIVE TENTHS (5.5) MILLS FOR A RESERVE ACCOUNT THAT WAS LEVIED FOR DUNKLIN FIRE DISTRICT FOR FY2023-2024; AND APPROVE A TOTAL INCREASE FOR FY2024-2025 OF FIVE AND FIVE TENTHS (5.5) MILLS FOR OPERATIONS AND 2.0 MILLS FOR A RESERVE ACCOUNT FOR A COMBINED TOTAL OF 37.4 MILLS ON SEPTEMBER 19, 2023 FOR A TOTAL MILLAGE OF THIRTY-FIVE AND FOUR TENTHS (5.5) MILLS FOR ONTINUING A TWO (2.0) MILL LEVY FOR A RESERVE ACCOUNT FOR A COMBINED TOTAL OF 37.4 MILLS ON SEPTEMBER 19, 2023 FOR A TOTAL MILLAGE OF THIRTY-FIVE AND FOUR TENTHS (3.5.4) MILLS AND CONTINUING TO THIS PUBLIC HEARING WILL NEED TO REGISTER ON-SITE BETWEEN 5:30 -6:00 P.M.
