



NOTICE OF PUBLIC HEARING

Notice is hereby given by the County Council of Greenville County, South Carolina (the "County Council") that the County Council will conduct a public hearing on the proposed adoption of an Ordinance entitled "AN ORDINANCE AUTHORIZING THE EXECUTION AND DELIVERY OF A FEE IN LIEU OF TAX AGREEMENT BY AND BETWEEN GREENVILLE COUNTY, SOUTH CAROLINA AND AUGUSTA GROVE 10 INVESTORS, LLC WITH RESPECT TO CERTAIN ECONOMIC DEVELOPMENT PROPERTY IN THE COUNTY, WHEREBY SUCH PROPERTY WILL BE SUBJECT TO CERTAIN PAYMENTS IN LIEU OF TAXES; AND OTHER MATTERS RELATED THERETO."

The public hearing will be held in the Greenville County Council Chambers located at 301 University Ridge, Greenville, South Carolina 29601, at 6:00 p.m. (or at such time as other public hearings are concluded), on Tuesday, March 18, 2025, in conjunction with a regularly scheduled meeting of the County Council.

Subject to the normal rules of County Council regarding appearances, individuals wishing to speak in favor or in opposition to this ordinance must register on-site between 5:15 and 5:45 the evening of the meeting. All citizens who appear will be given an opportunity to express their views for or against the adoption of the ordinance.
