# **Approval of Minutes:**

### MR. JIM LAKE, DIRECTOR OF CHARLESTON CONSOLIDATED DISPATCH CENTER

Chairman Collins introduced Mr. Jim Lake, Director of the Charleston County Emergency Communications Center. He was invited to present Charleston County's ideas, pros, cons and implementation of their consolidated dispatch center to the Public Safety Committee. During his presentation, he covered the following topics:

- Call Volume in 2024
- Performance Metrics for 2024 & 2025
- Traditional and Non-Traditional Agencies Served within the consolidation

- 9-1-1 Consolidation Cons
- Shared Systems
- Fiscal Costs
- Consolidation Achievements
- Lessons Learned

Mr. Lake concluded his presentation and asked the committee if they had any questions.

Councilor Russo asked several questions regarding costs of the consolidated facility, pros and cons, and the challenges of integrating dispatchers. Mr. Lake addressed each question with stats, costs, development strategies and incentives.

Councilor Farmer asked if call time response improved after the consolidation. Mr. Lake shared the progress from agencies who were tracking those numbers.

Councilor Shaw asked what the first steps were to starting a consolidation effort. Mr. Lake recommended having a conversation with all the agencies Greenville County would want to consolidate.

Chairman Collins asked about the diversified dispatch process and suggestions on ambulatory service integration. Mr. Lake shared the dispatch integration, incentives, and employee response outcomes throughout the process, as well as, Charleston County's procedure for dispatching calls for ambulance services.
