Project Description

The 5" Supply hose replacement is a critical equipment replacement project focused on improving the operational readiness, reliability, and safety of Clear Spring Fire and Rescue's water supply operations through the replacement of aging 5" large diameter fire hose.

Large diameter hose serves as the backbone of fire suppression operations by providing sustained water flow from hydrants and relay pumping operations to frontline apparatus during emergency incidents. As hose ages, it becomes increasingly susceptible to wear, damage, coupling failure, and reduced performance, creating potential operational and safety concerns on the fireground.


This project will provide replacement 5" hose sections to ensure dependable water delivery capabilities during residential, commercial, and auto/mutual aid incidents. The initiative will also support, improve deployment efficiency, and enhance interoperability during multi-agency responses.

By investing in upgraded hose infrastructure, Clear Spring Fire and Rescue will strengthen operational effectiveness, support ISO preparedness efforts, and reduce the likelihood of costly emergency hose failures or unplanned replacements in the future.
