

PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the Greenville County Council during a regular meeting in Council Chambers, 301 University Ridge, Greenville, on Tuesday, July 21, 2026, at 6:00 p.m., *(or as soon thereafter as other hearings are concluded)*, for the purpose of determining whether the boundaries of the Greater Greenville Sanitation District should be enlarged to include those certain properties located in the Willimon Estates Subdivision, Piedmont, for the purpose of collecting and disposing of refuse, garbage and trash within Greenville County.
