

**A RESOLUTION**

**TO ENLARGE THE BOUNDARIES OF THE GREATER GREENVILLE SANITATION DISTRICT TO INCLUDE WILLIMON ESTATES SUBDIVISION.**

**WHEREAS**, pursuant to the provisions of Title 6, Chapter 11, Article 3 of the Code of Laws of South Carolina, 1976, as amended (the “*South Carolina Code*”), the governing bodies of the several counties of the State are authorized to enlarge, diminish, or consolidate any existing special purpose districts created prior to March, 1973 that are located within such counties; and

**WHEREAS**, Greenville County Council is the governing body of Greenville County, South Carolina; and

**WHEREAS**, the Greater Greenville Sanitation District (the “*District*”) was created by Act No. 1543 of the 1968 Acts and Joint Resolutions of the General Assembly of the State of South Carolina, as amended, and is authorized to collect refuse, garbage, and trash within and outside the District; and

**WHEREAS**, the District has submitted a petition to Greenville County Council on District letterhead purporting to have been signed by the property owners of a majority of properties in Willimon Estates Subdivision, further described on the attached Exhibits (collectively the “*Properties*”), to have the Properties annexed into and made a part of the District.

**WHEREAS**, the Greater Greenville Sanitation District Commission has consented to the annexation of the Properties into the District; and

**WHEREAS**, Greenville County Council finds that the Properties are located wholly within the boundaries of Greenville County, South Carolina, and are not located within any special purpose district or municipality empowered to provide trash collection and expansion of the boundaries to include the Properties will provide for the orderly collection of refuse, garbage, and trash within the District; and

**WHEREAS**, Greenville County Council finds that it is in the public interest that the boundaries of the District are enlarged to include the Properties.

**NOW, THEREFORE, BE IT RESOLVED** by Greenville County Council that the boundaries of the Greater Greenville Sanitation District are hereby enlarged to include the Properties, and that pursuant to S.C. Code § 6-11-470, the Clerk of the County Council shall cause to be published in a newspaper of general circulation in Greenville County, once a week for two successive weeks the following information:

- (a) the results of this action of the Greenville County Council;
- (b) the fact that this Resolution does not authorize the issuance of additional bonds by the Greater Greenville Sanitation District; and

- (c) the fact that there will be no new Commission or changes made in the personnel of the present Commission of the Greater Greenville Sanitation District.
