# GCHRC commits to the financial future of Upstate Veterans

Greenville County is home to approximately 37,000 armed forces veterans and their families. According to a recent survey from the National Federation for Credit Counseling, veterans are almost twice as likely as civilians to have debt that carries over month to month (58%), and nearly the same number (55%) believe they are ill prepared for a financial emergency. This is not due to any fault of the veterans, it is because of a lack of financial literacy.

"As a United States Air Force Veteran it was difficult for me to budget my money when I first entered civilian life. I had always had allowances dedicated to housing and food. Thanks to GCHRC I was able to get my budget under control and start saving for my first home.

Entering the civilian workforce after years of military service requires veterans to learn all types of new skills, and we at GCHRC want to arm our veterans with the financial skills necessary to make their civilian lives as successful as their service lives. We are partnering with Greenville VA Outpatient clinic, HUD's Veterans Affairs Supportive Housing program, Upstate Warrior Solution, and Greenville County Veterans Affairs to bring free financial literacy workshops, first-time homebuyer education courses, and credit counseling to all veterans county wide. # Greenville Housing Authority & GCHRC team up for Home Ownership 101

GCHRC has partnered with the Greenville Housing Authority (GHA) to introduce the Homeownership 101 course. This program involves 8 hours of classroom based education centered upon credit and the home buying process. Beyond the classroom, each individual meets with a GCHRC housing counselor to complete an individual assessment and to formulate a clear and concise plan of action that will set them on the path towards homeownership. Course participants are current members of GHA's Family Self-Sufficiency program and upon completion of that program could be eligible to utilize their Housing Choice Voucher towards a home of their own.

In the last six months, eleven individuals have completed the Homebuyer 101 course, and one participant has already become a homeowner!

Since August, 18 individuals have participated in the program. One individual has purchased a home, and two other individuals are scheduled to close on homes this year. All HO 101 participants have raised their credit score and continue to receive one on one monitoring. GCHRC is excited to continue this partnership with GHA and is as committed as ever to assisting the individuals and families of Greenville County achieve their dream of homeownership.

### SC Help keeps on helping!

SC HELP was launched in January 2011 to help responsible South Carolina homeowners who are struggling to make their mortgage payments stay in their homes during hard financial times. There is no cost to you to apply for SC HELP. Remember: If anyone asks you to pay for mortgage help, it may be a scam. GCHRC has trained SC HELP case workers on staff who are dedicated to helping you stay in your home. SC HELP provides monthly payment assistance, direct loan assistance, transition assistance, and modification/recast assistance. ### Fair Housing Compliance 2017



Each year GCHRC holds an annual Fair Housing Compliance Training event to help educate our local housing community on new rules and regulations enacted by the United States Office of Housing and Urban Development (HUD). The Fair Housing Act of 1968 is enormously complex and far-reaching, it prohibits discrimination concerning the sale, rental and financing of

housing based on race, religion, national origin and sex. The staff of GCHRC from its inception has been committed to eradicating discriminatory practices in our community, be it housing or otherwise. This years training led by moderators from the Greenville Housing Authority and BB&T included information for landlords, tenants, builders, mortgage providers, and real estate agents. Representatives from South Carolina Human Affair, SC Department of Justice, and Housing and Urban Development brought their expertise on subjects ranging from basic compliance of fair housing laws to rights for ex-offenders and
