AN ORDINANCE

AN ORDINANCE TO REORGANIZE AND RESTRUCTURE CERTAIN BOARDS AND COMMISSIONS IN GREENVILLE COUNTY AND TO PROVIDE FOR THE APPOINTMENT AND TERMS OF BOARD AND COMMISSION MEMBERS.

BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:

Section 1. Definitions. As used herein, the term "board" or "commission", or the words "board and commission" shall include the following:

- ✓ The Greenville County Commission on Alcohol and Drug Abuse;
- ✓ The Board of Assessment Appeals;
- ✓ The Building and Housing Board of Adjustments and Appeals;
- ✓ The Citizens Crime Commission;
- ✓ The Greenville County Civil Defense Agency; ~~deleted~~
- ✓ The Emergency Medical Services Commission; ~~deleted~~
- ✓ The Greenville County Board of Health;
- ✓ The Grady H. Hipp Nursing Center Board;
- ✓ The Greenville County Historic Preservation Commission;
- ✓ The Greenville County Human Relations Commission;
- ✓ The Greenville County Mental Retardation Board;
- ✓ The Greenville County Museum Commission;
- ✓ The Greenville County Planning and Development Board;
- ✓ The Greenville County Redevelopment Authority;
- ✓ The Greenville County Retirement Center Board.

Section 2. Members of boards and commissions serving on the effective date of this Ordinance, shall continue to serve until the date upon which their current terms expire, and shall thereafter be eligible for reappointment to one additional three-year term unless two or more such members reside in the same House or Council Districts, and in that event only one such member shall be eligible for reappointment. A new member shall be appointed for one three-year term, and shall be eligible for reappointment to an additional

three-year term, but no member shall serve for more than two consecutive three-year terms. However, should a term be shortened during the implementation phase of this ordinance, an individual appointed to a term of less than two years shall be eligible for reappointment to two subsequent three-year terms.

Section 3. The following boards and commissions shall be composed of twelve (12) resident electors of the County. New members shall be residents of each of the twelve House or Council districts not currently represented on such boards and commissions and shall be appointed by the County Council to take office in accordance with the following schedule.

(a) The Greenville County Commission on Alcohol and Drug Abuse. One member shall be appointed as soon as practicable to fill the vacancy created by the expiration of a term which ended May 30, 1979; with the term to begin on the date of appointment and expire May 30, 1982.

(b) The Board of Assessment Appeals. One member shall be appointed as soon as practicable to fill the vacancy created by the expiration of a term which ended September 15, 1979, with the term to begin on the date of appointment and expire September 30, 1982. Seven additional members shall be appointed during the month of September for terms commencing on October 1, 1980, as follows:

For one-year terms: three members

For two-year terms: two members

For three-year terms: two members

(c) The Citizens Crime Commission. Five additional members shall be appointed during the month of April for terms commencing on May 1, 1980, as follows:

For one-year terms: two members

For two-year terms: two members

For three-year terms: one member

(d) The Greenville County Civil Defense Agency.

Seven additional members shall be appointed during the month of July for terms commencing on August 1, 1980, as follows:

For one-year terms: two members

For two-year terms: four members

For three-year terms: one member

(e) The Emergency Medical Services Commission.

Five additional members shall be appointed during the month of April for terms commencing on May 1, 1980, as follows:

For one-year terms: two members

For two-year terms: two members

For three-year terms: one member

(f) The Greenville County Board of Health. Four additional members shall be appointed during

the month of April for terms commencing on May 1, 1980, as follows:

For one-year terms: four members

(g) The Grady H. Hipp Nursing Center Board.

Five additional members shall be appointed during the month of November for terms commencing on December 1, 1980, as follows:

For one-year terms: two members

For two-year terms: two members

For three-year terms: one member

(h) The Greenville County Historic Preservation

Commission. Five additional members shall be appointed during the month of June for terms commencing on July 1, 1980, as follows:

For one-year terms: one member

For two-year terms: four members

(i) The Greenville County Human Relations Commission.

In January of 1981, the terms of nine (9) members shall expire. At that time, three of these positions shall be retired, and six individuals shall be appointed for three-year terms.

(j) The Greenville County Mental Retardation Board.

Five additional members shall be appointed during the month of April for terms commencing on May 1, 1980, as follows:

For one-year terms: one member

For two-year terms: three members

For three-year terms: one member

(k) The Greenville County Museum Commission. To facilitate the implementation of this Ordinance, the terms of two incumbent members which would normally expire on June 30, 1985, shall instead expire on June 30, 1983. Six additional members shall be appointed during the month of June for terms commencing on July 1, 1980, as follows:

For one-year terms: two members

For two-year terms: four members

(l) The Greenville County Retirement Center Board.

One member shall be appointed as soon as practicable to fill the vacancy created by the expiration of a term which ended on February 28, 1979, with the term to begin on the date of appointment and expire February 28, 1982. Five additional members shall be appointed during the month of March with terms commencing on the date of appointment and expiring February 28, during the last year of each member's term, as follows:

For two-year terms: one member

For three-year terms: four members

Section 4. The following Boards shall each be composed of five members, and insofar as possible there shall be only one member residing in a particular House or Council District serving on each of the two Boards listed herein.

(a) The Building and Housing Board of Adjustments and Appeals. The five members serving on what was formerly known as the Board of Adjustments and Appeals shall compose the newly created Building and Housing Board of Adjustments and Appeals and shall serve three-year terms in accordance with the provisions of Ordinance No. 791.

(b) The Greenville County Planning and Development Board. One member shall be appointed as soon as practicable to fill the vacancy created by the expiration of a term which ended December 1, 1979, with the term to begin on the date of appointment and expire December 1, 1982. Two additional members shall be appointed during the month of November for terms commencing on December 1, 1980, as follows:

For two-year terms: one member

For three-year terms: one member

Section 5. The following Board shall be composed of seven (7) resident electors of the County, and insofar as possible there shall be only one member in a particular House or Council District serving on the Board listed herein.

The Greenville County Redevelopment Authority.

To facilitate the implementation of this Ordinance, the term of one incumbent member which would normally expire on October 4, 1984, shall instead expire on October 1, 1983. Two additional members shall be appointed during the month of September

for terms commencing on October 1, 1980, as follows:

For one-year terms: one member

For two-year terms: one member

Section 6. Reports; Ex-Officio Members. Each board or commission shall make periodic reports, no less frequently than once a year, to the Greenville County Council, summarizing its activities and showing its financial status.

In those cases in which legislation makes provision for ex-officio members, such ex-officio members shall continue to serve for the terms and under the conditions provided by such legislation and shall be entitled to vote.

Section 7. Vacancies. Vacancies occurring by reason of death, disability, resignation, or other cause shall be filled by the County Council for the remainder of the unexpired term.

Section 8. The following Acts of the General Assembly of the State of South Carolina, as the same have been from time to time amended, are further amended so as to incorporate the above changes:

- (a) Act No. 140 of 1973 (The Greenville County Commission on Alcohol and Drug Abuse)
- (b) Act No. 605 of 1967 (The Greenville County Civil Defense Agency)
- (c) Act No. 974 of 1966 (The Greenville County Board of Health)
- (d) Act No. 766 of 1966 (The Grady H. Hipp Nursing Center Board)
- (e) Act No. 833 of 1970 (The Greenville County Historic Preservation Commission)
- (f) Act No. 1832 of 1972 (The Greenville County Human Relations Commission)

- (g) Act No. 8 of 1971 (The Greenville County Mental Retardation Board)
- (h) Act No. 537 of 1963 (The Greenville County Museum Commission)
- (i) Act No. 223 of 1959 (The Greenville County Planning and Development Board)
- (j) Act No. 516 of 1969 (The Greenville County Redevelopment Authority)
- (k) Act No. 118 of 1949 (The Greenville County Retirement Center Board)

Except as herein amended, such Acts shall remain in full force and effect as ordinances of Greenville County.

Section 9. The following Ordinances of the Greenville County Council, as same have been from time to time amended, are hereby further amended so as to incorporate the above changes:

- (a) Ordinance No. 535 (The Board of Assessment Appeals)
- (b) Ordinance No. 437 (The Citizens Crime Commission)
- (c) Ordinance No. 317 (The Emergency Medical Services Commission)

Section 10. This Ordinance is authorized by Section 3 of Act No. 283 of the 1975 Acts and Joint Resolutions of the General Assembly of South Carolina.

Section 11. This Ordinance shall take effect upon the date of its adoption.
