

AN ORDINANCE

AN ORDINANCE TO CREATE A JOINT TRANSIT AUTHORITY FOR THE CITY AND COUNTY OF GREENVILLE IN CONFORMITY WITH CHAPTER 25, TITLE 58 OF THE CODE OF LAWS OF SOUTH CAROLINA (1976), AS AMENDED.

BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:

Section 1. Created. There is hereby created a joint Transit Authority for the City and County of Greenville, South Carolina, pursuant to and in conformity with Chapter 25, Title 58 of the Code of Laws of South Carolina (1976), as amended, to be known as the Greenville Transit Authority.

Section 2. Appointment; term of members. The Greenville City Council and the Greenville County Council shall each appoint two (2) members to the governing board of the Greenville Transit Authority. The Greenville County Legislative Delegation shall appoint up to three (3) additional members. The term of office of each member of the governing board shall be three (3) years and until a successor has been appointed and qualified; provided, however, that the terms of office of board members serving or to be appointed on the effective date of this ordinance shall expire as follows:

1. Legislative Delegation Appointee -- 12/31/91
2. Legislative Delegation Appointee -- 12/31/91
3. Legislative Delegation Appointee -- 12/31/91
4. City of Greenville Appointee -- 12/31/89
5. City of Greenville Appointee -- 12/31/90
6. County of Greenville Appointee -- 12/31/89
7. County of Greenville Appointee -- 12/31/90

Section 3. Compensation of members. The members of the governing board shall receive no compensation for their services, but shall be entitled to all necessary expenses, including travel expenses, incurred in the discharge of their duties as a board member.

Section 4. Filing of Certificates of appointment of members. A certificate of each appointment of a member of the governing board shall be filed with the official records of the City and the County, and such certificates shall be conclusive evidence of their due and proper appointment.

Section 5. General powers, duties, and responsibilities. The authority shall be vested with all the powers, duties, and responsibilities as set forth in Chapter 25, Title 58 of the Code of Laws of South Carolina (1976), as amended.

Section 6. Authority of city and county council. The Greenville City Council and the Greenville County Council may further define the powers of the Greenville Transit Authority and prescribe all necessary rules and regulations for the orderly carrying out of the purposes of the Authority as specifically granted in Chapter 25, Title 58 of the Code of Laws of South Carolina (1976), as amended.

Section 7. Repeal. Ordinance No. 355, adopted by Greenville County Council on October 16, 1974, is hereby repealed.

Section 8. Effective Date. This ordinance shall take effect upon the date of its adoption.
